Re: Life Education 2024 – Year 6

From Wednesday 24th of July, Year 6 students at Pallara State school will have the opportunity to take part in Life Education classes. In this updated module, students investigate the importance of respectful relationships for wellbeing, including face to face and online connections.

Students explore how the physical and personal changes at this stage of life impact their behaviour, emotions and relationships. They also learn to recognise, react and report disrespectful, unsafe and potentially predatory behaviour online. They key areas covered include:

- Concepts such as respect, empathy and consent
- Understanding the characteristics of, and importance of respectful relationships
- Recognising body clues
- Reacting to, and reporting (help seeking) unsafe online behaviour
